

Description

Over the past two decades, inland waterways, transport corridors, and urban harbor districts have increasingly attracted attention from both business and politics, particularly in areas such as transport, trade, and housing. This interest has extended to academia, where sociological aspects of urban development and historical perspectives on waterways as enablers of the circulation of knowledge, people, and goods have been explored.

However, the port facilities and harbor districts along the Danube have received limited scientific attention, despite the significant role the Danube waterway played in the economic development of Central and Southeastern Europe in the 19th century. The Danube's ports were vital hubs, fostering maritime culture, industrialization, and cultural diversity.

These dynamics shaped urbanization, regional and transregional exchanges, and the interaction between centers and peripheries. This workshop aims to bring together researchers to discuss the development, function, socio-economic impacts, and future of Danube ports, including their decline and revitalization efforts.

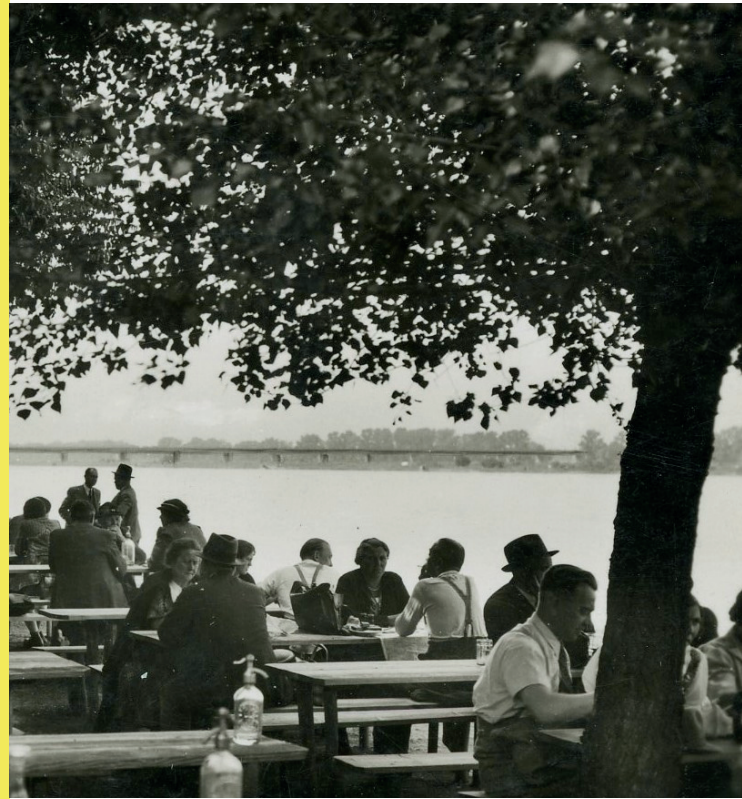
